DEAR MUSANA FAMILY,

2020 started off as a year of unmatched growth at Musana, reaching 112% self-sustainability in February and generating our highest local monthly income in our organization's history. With the launch of our replication campus in Kaliro District, we opened our fourth school, providing quality and affordable education in a new community! Between all of our schools, our student population grew from 2,282 to 3,484 and our full-time employees increased from 282 to 383. Unfortunately, like most of the world, the COVID-19 pandemic hit Uganda hard in March and one of the world's strictest lockdowns began. We saw hunger, idleness, and hopelessness spread across our communities. We started the COVID-19 Relief Fund and asked our Musana family to stand with us and meet the immediate needs of our Ugandan friends and family. With your support, we were able to prevent widespread hunger in our immediate neighborhoods, provide life-saving medical transport and health services, save countless lives by collecting blood donations, keep our staff on salary so that they could continue to support their families, and provide our students with workbooks to keep their spirits engaged and their minds active.

Despite the closure of our schools (our highest income-generator), the decrease in clients at our restaurant and guesthouse, and the decline of patients at our hospital due to COVID restrictions, we were still able to generate 65% of our operating budget locally. We are proud of the hard work from our team on the ground that fought hard to keep Musana's programs alive through such unfavorable circumstances

We cannot thank our incredible Musana community enough for standing with us during unprecedented times. We are overwhelmed by the generosity of our Musana family and the love for the people of Uganda. Together, we will continue to empower more men, women, and children, to "be the change" in their communities

2020 HIGHLIGHTS



In January 2020 **we opened the Kaliro Campus to 682 nursery and primary school students!** In addition, we completed construction of the dining hall, additional dormitories and classrooms, and a beautiful school chapel.



We grew our staff of local leaders from 282 employees in 2019 to **383 full-time Ugandan employees** in 2020!



With the **\$268,221** raised for the COVID-19 Relief Fund, we **met new school health regulations, supported the salaries of 383 employees, distributed 3,008 sets of self-study materials to students at home, provided 1,000+ life-saving blood transfusions, transported 555+ patients to treatment centers, and supplied food for 18,600+ people facing hunger** in Eastern Uganda.



We rose to the challenge of holding an annual fundraiser amidst the local COVID-19 regulations in Denver, Colorado, and **safely held the 3rd annual Taste To Transform event where** we raised \$460,228!



We partnered with Uganda Orphans Fund and started *planning our next replication in Kamuli District!*





In March, COVID-19 was declared a global pandemic. The impact was sudden, with the most detrimental consequences taking root in rural areas already facing the challenges of poverty.

Like most of the world, schools in Uganda were closed, jobs were lost, community gatherings were prohibited, and new preventative health mandates were instituted. However, unlike many developed parts of the world, communities in rural Uganda had a lack of access to educational materials and increased difficulty accessing health care.

EDUCATION

15 million Ugandan children remained out of school through the end of the year, including 3,484 students who filled four of Musana's schools at the beginning of 2020. To respond to the urgent needs of our students, we made the decision to temporarily shift our model from growth and sustainability to relief and rehabilitation with a mission to reopen our schools and respond to urgent needs of the communities in and around Iganga. Through the generous donations of those looking outside their borders, the COVID-19 Relief Fund raised \$268,221 which allowed Musana to successfully sustain the salaries of 383 full-time employees and implement newly mandated safety measures across our campuses. By the end of the year, we successfully met new preventative health regulations required to **reoben our cambuses.** In preparation for students to return. hand-washing stations were installed, temperature scanners were put to use, masks were made by women at Musana's Empowerment Center, isolation wards were prepared, and additional beds, desks and tables were purchased. The COVID-19 Relief Fund also provided for the development and distribution of 3,008 sets of self-study materials to our students in nursery, primary and high school to encourage continued learning during school closures.

Fortunately, the government resumed schooling for graduating classes in October, which allowed us to welcome 291 students back to campus!









COMMUNITY HEALTH

BLOOD DONATIONS

In March 2020, the Uganda Blood Bank was hit with a major blood shortage, putting the lives of patients with malaria, sickle cell anemia, and mothers giving birth at stake. With volunteer donors as the only source of blood, Musana Community Health Center spearheaded educating and mobilizing communities in and around Iganga to donate. From April through June, three blood donation tents were set up to collect blood and provide health education to the community.

TRANSPORTATION

At the onset of the pandemic, the Ugandan government banned public transportation and instituted a nationwide curfew in an effort to curb the spread of the virus. As a result, patients living in rural areas faced extreme difficulty accessing health services, many in need of care for childbirth, malaria, typhoid, dental care, and sickle cell anemia. Adjusting to the evolving needs of the community, Musana's Social Work Department repurposed two school vans into interim ambulances that successfully transported 555+ patients to medical facilities for life-saving care!

FOOD PACKAGES

Food shortages and reduced food portions became an increasing challenge for families as they suffered the impact of lost jobs and supporting children who were no longer receiving meals from school. To combat hunger and malnutrition, Musana's Social Work Department distributed food packages to those in dire need of nutrition.



AN AWARD FOR **INNOVATION**

At the start of the year, Stanbic Bank held the National Schools Championship, an education initiative empowering participants to write a business proposal focused on agriculture or business innovation.

A group of motivated students from Musana Vocational High School entered the competition with their idea to locally produce liquid soap that could be used in households to enhance hygiene. With the sudden arrival of COVID-19, their idea became hyperrelevant and could serve an urgent need in their community.

The team's liquid soap idea qualified for the Eastern Region Championship where they came in 4th out of 21 participating schools and won \$140 to be used as seed capital for the start-up! Following the competition, the team of students invested the capital into production and by July were making deliveries of their soap to the community, including supplying Musana campuses with soap for newly installed hand-washing stations!

OUTREACH

In the most rural areas of Iganga, access to health care is challenging. In response to the needs of these communities, Musana's Social Work Department partners with Musana Community Health Center and remote village leaders to organize health outreach events. During health outreach events, social workers and health practitioners travel to rural areas of Iganga to provide free services including malaria and HIV testing, dental check-ups and extractions, family planning, prenatal care, nutrition screenings, vaccinations, and counseling. Prior to the COVID-19 lockdown in March, our team **provided outreach services to 660 people**.

PROJECT RESTORE

Project Restore seeks out the most vulnerable children and adults in dire health, and those living with disabilities, to provide them with proper medical attention through surgeries and rehabilitation. The dream is that once they are "restored", they will be able to live independent lives and give back to their communities. In 2020, medical assistance was provided for 88 people suffering from severe cases of malaria, anemia, hydrocephalus, cleft palate, dermatological conditions, Hepatitis B, HIV/Aids, and hearing and visual impairment.

REHABILITATION & DISABILITY SERVICES

A unique focus at Musana Community Health Center is one led by the Rehabilitation & Disability Services Department. The department is aimed at improving the quality of life for individuals with disabilities and to promote inclusion among the community. Our full-time physiotherapist provides inpatient and outpatient treatment for fractures, pediatric conditions, stroke recovery, and chronic illness management, among other conditions. Our occupational therapist concentrates on community-based rehabilitation and parent education programs. By partnering with other local organizations to mobilize individuals with disabilities, and parents of children with disabilities, we create a support network and improve access to services. In 2020, the **Physiotherapy & Occupational Therapy Clinic conducted 982 visits, treated 366 new patients, and visited 444 patients that required home care.**

MAIMUNAH'S STORY

In 2019, 10-year-old Maimunah lives with a congenital amputation of her right leg. When she was identified by our occupational therapist, she was living with her father, who was a truck driver, and mother who cared for her and her three siblings. Maimunah's disability and her parents' limited financial resources restricted her access to education.

In 2020, our Rehabilitation & Disability Services and Social Work Department enrolled Maimunah in our Education Scholarship Program and provided her with a wheelchair. At school, Maimunah quickly made friends who helped her maneuver around campus, class and in the dormitory. She had a joyful spark that lit up the room!

Three short months after her arrival to Musana, schools were ordered to close due to COVID-19. During school closures, our Social Work Department organized home visits and Maimunah was provided with health check-ups, food packages, and reading materials. It's now almost a year since schools were closed and Maimunah expresses how much she misses school, her friends and her teachers. She is eager to get back and plans to work hard to become a teacher so that she can also impart knowledge to other learners in her community!

As one of the longest term employees of Musana, Dorcus has been extremely dedicated to her work. Starting as a caretaker in one of the student dormitories, she then transitioned to the role of staff cook, and later was promoted to her current position as Guest House Supervisor. Ever smiling and diligent in her work, she is known for having the most vibrant and uplifting spirit among staff members and visitors alike. "Her joy for life radiates," a guest house visitor noted as she described how they would wake to the sounds of Dorcus singing while cooking breakfast! Through her employment, Dorcus has been able to support and educate all three of her children, two of who now have university level education, and her youngest, Ezekiel, who attends Musana Primary School (P.6).

For the years to come, she prays that God will continue to guide Musana's leadership and bless its partners so that Musana can continue transforming communities and expanding throughout rural Uganda.



Musana is comprised of two separate legal entities that each maintain their own financial records. Although there is some overlap, Program activities are run by the non-governmental organization (NGO) registered in Uganda, recorded in Uganda shillings, and the Administrative & General and Fundraising activities are recorded by the Colorado non-profit corporation Musana Community Development Organization (MCDO). This financial report is a consolidation of both entities, unless otherwise specified. All amounts are in U.S. dollars. Ugandan shillings






Despite all schools being closed for a majority of the year, we were able to achieve 65% overall sustainability across Musana's social enterprises.








SUSTAINABILITY BY PROGRAM IN 2020
