Musana focuses on creating social enterprises in the areas of education, health, and skill development. In 2023, Musana employed 577 Ugandans with full-time work, educated 4,639 youth with 1,849 students on scholarship, and had 36,408 patient visits at Musana Community Health Centers. Musana also operates other income generating activities like guesthouses, a restaurant, and merchandise production. In 2023 NGO programs were 95% self-sustaining.

MCDO is currently concentrating on replicating into two locations; Kaliro and Kamuli District. In 2023, the following work was done in Kaliro: Construction and furnishing the vocational high school, construction and furnishing a guesthouse, and minor expansion projects at the primary school. In Kamuli, the following work was done: construction of a nursery school building and dormitory at the nursery and primary school, construction and furnishing of a hospital, and purchase of land for a hotel.
