Operating - Support operating activities at the NGO in Uganda. Money is used to supplement program income generated from enterprises in farming (dairy, piggery, goats, and crop production), bakery, restaurant, guesthouse, crafts, and school.

Support for capital development in Iganga, Uganda. Construction continued on the Health Center which opened in February 2016. The NGO made significant capital investment in all areas of education and children's living accommodations. A new Nursery School building was completed and construction continued on the Secondary School. New furnishings were purchased for the children's dormitories and classrooms. Additions were made to accommodations for volunteers. The first payment was made on property in the town of Iganga that will be renovated to include hotel rooms, a restaurant and conference rooms. Capital purchases for the farm included dairy cows, goats and farm equipment.
