MUSANA FOCUSES ON CREATING SOCIAL ENTERPRISES IN THE AREAS OF EDUCATION, HEALTH, AND SKILL DEVELOPMENT. IN 2022, MUSANA EMPLOYED 509 UGANDANS WITH FULL-TIME WORK, EDUCATED 5,400 YOUTH WITH 1,753 STUDENTS ON SCHOLARSHIP, AND HAD 31,992+ PATIENT VISITS AT MUSANA COMMUNITY HEALTH CENTERS. MUSANA ALSO OPERATES OTHER INCOME GENERATING ACTIVITIES LIKE A GUESTHOUSE, A RESTAURANT, AND MERCHANDISE PRODUCTION. THE GLOBAL COVID-19 PANDEMIC CAUSED SIGNIFICANT DISRUPTION TO THE ACTIVITIES OF THE NGO IN UGANDA IN 2021. NGO PROGRAMS WERE 93% SELF-SUSTAINING IN 2019 BUT DECREASED TO 59% IN 2021 DUE TO THE CONTINUED CLOSURE OF SCHOOLS AND INCOME GENERATING BUSINESSES. IN 2022 NGO PROGRAMS WERE 90% SELF-SUSTAINING AS PROGRAMS RAN WITHOUT THESE SAME DISRUPTIONS.
